

DATA PRIVACY NOTICE

Oxford Region Girtonians (ORG)

1. Your personal data – what is it?

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation 2018 (the "GDPR").

2. Who are we?

The Committee of ORG is the data controller (contact details below). This means it decides how your personal data is processed and for what purposes.

3. How do we process your personal data?

The Committee of ORG complies with its obligations under the "GDPR" by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

We may use your personal data for the following purposes:

- To administer membership records;
- To inform you of news, events, activities relating to the work of ORG;
- To promote the interests of the organisation;
- To maintain our own accounts and records;
- To share your contact details with Girton College so they can keep you informed about news, events and activities relating to the college in which you may be interested.

4. What is the legal basis for processing your personal data?

- Explicit consent of the data subject;
- Processing is necessary for compliance with a legal obligation.

5. Sharing your personal data

Your personal data will be treated as strictly confidential and will only be shared with other members of ORG in order to carry out specific actions for the running of ORG. We will only share your data with third parties outside ORG with your consent.

6. How long do we keep your personal data?

We keep data for three years after the current recording year (ending 30th September).

7. Your rights and your personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data:

- The right to request a copy of your personal data which the Committee of ORG holds about you;
- The right to request that the Committee of ORG corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for the Committee of ORG to retain such data;
- The right to withdraw your consent to the processing at any time;

- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to lodge a complaint with the Information Commissioner's Office.

8. Further processing

If we wish to use your personal data for a new purpose, not covered by this Data Privacy Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.
